BOND RULES

1. After 3 missed check-ins, YOUR BOND(s) may be SURRENDERED.
2. As a courtesy, we will remind defendants of their courts dates, but it is the responsibility of the co-signer and the defendant to know when, where, and what time the defendant is to appear in court.
3. As the co-signer, you have obligated yourself LEGALLY and you will be held LEGALLY responsible for any debt ALL ABOUT BAIL BONDS incurs relating to the case(s) you co-signed for.
4. You must notify ALL ABOUT BAIL BONDS each time you report to court. It is VERY important that you inform use of your new court dates.
5. Defendant must come into the office and complete their paperwork within twenty-four (24) hours after their release from jail.
6. You must notify ALL ABOUT BAIL BONDS of any changes to your address, telephone numbers, or employment within 48 hours.
7. Defendants must provide ALL ABOUT BAIL BONDS with his/her attorney's name, telephone, and address.
8. During the term of the bond(s), you may not leave the county of your residence, the state of Texas, the United States, or the country.
9. A representative of ALL ABOUT BAIL BONDS may, at any time, contact you by phone or in person, at home, or at your place of employment during the term of the bond(s).
10. When a defendant's case(s) are disposed of, any balances remaining are due in full IMMEDIATELY.
11. Any balances remaining and/or any fees incurred by ALL ABOUT BAIL BONDS relating to the defendant, will be pursued LEGALLY by having a case(s) filed against the co-signer(s) and or defendant in the appropriate court(s).
12. For all returned unused Powers, there will be a \$100.00 administrative fee charged. VOIDED POWER FEE.
13. For all Large Bonds (single bond (s) over \$100,000.00), there will be a \$150.00 administrative fee charged. PAPERWORK PROCESSING FEE.
